6. Sealed of Electronic bids must be submitted to the office of Ghorahi Sub-Metropolitan City through web portal www.bolpatra.gov.np/egp on or before 12:00 on 2080/04/30 BS Bids received after this deadline will be rejected.

7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 pm, 2080/03/30 BSat the office of Ghorahi, Dang. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of above mention which shall be valid for 30 days beyond the validity period of the bid. (ie 120 days)

8. If the last date of Pre-Bid meeting/purchasing/submission day falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
